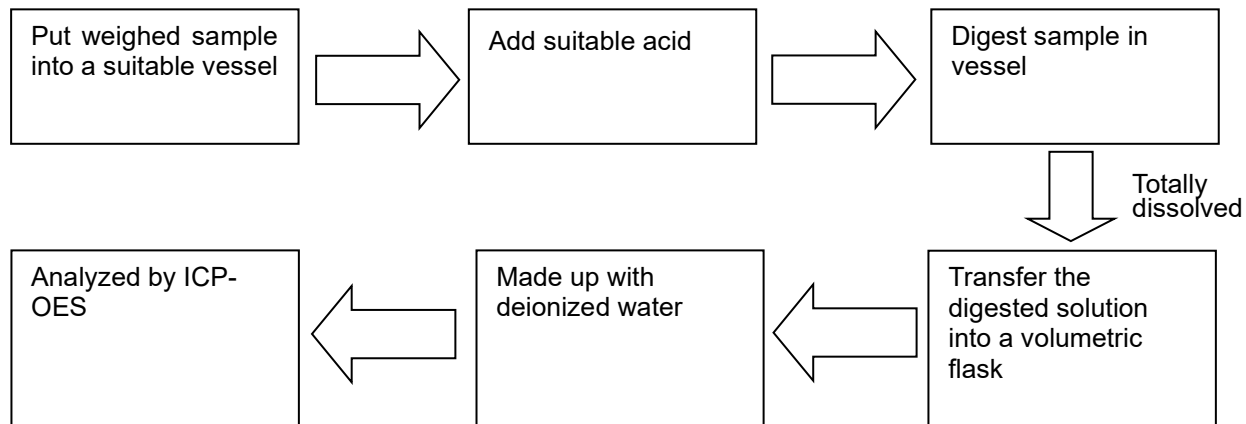

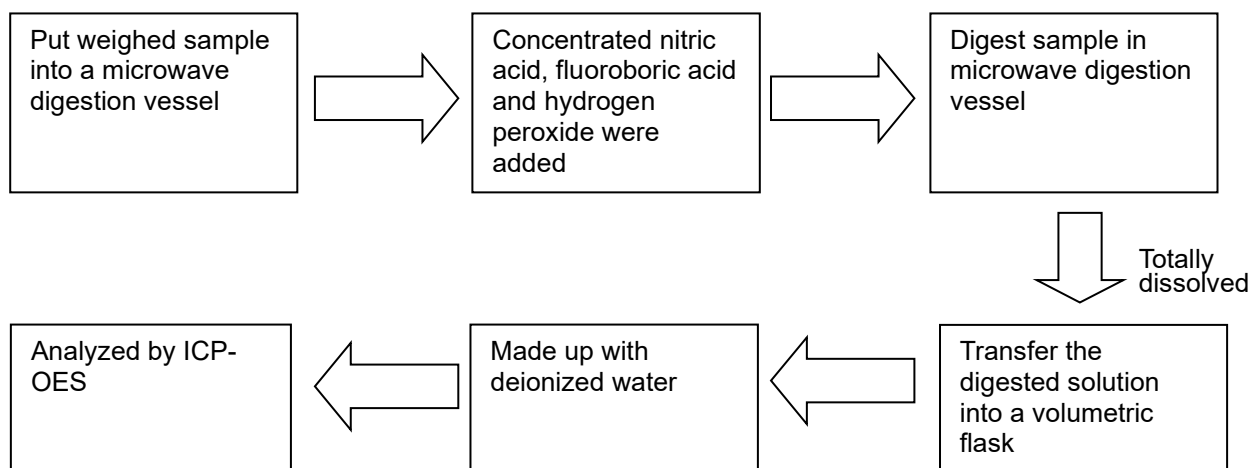

1. Test for Cd/Pb Contents

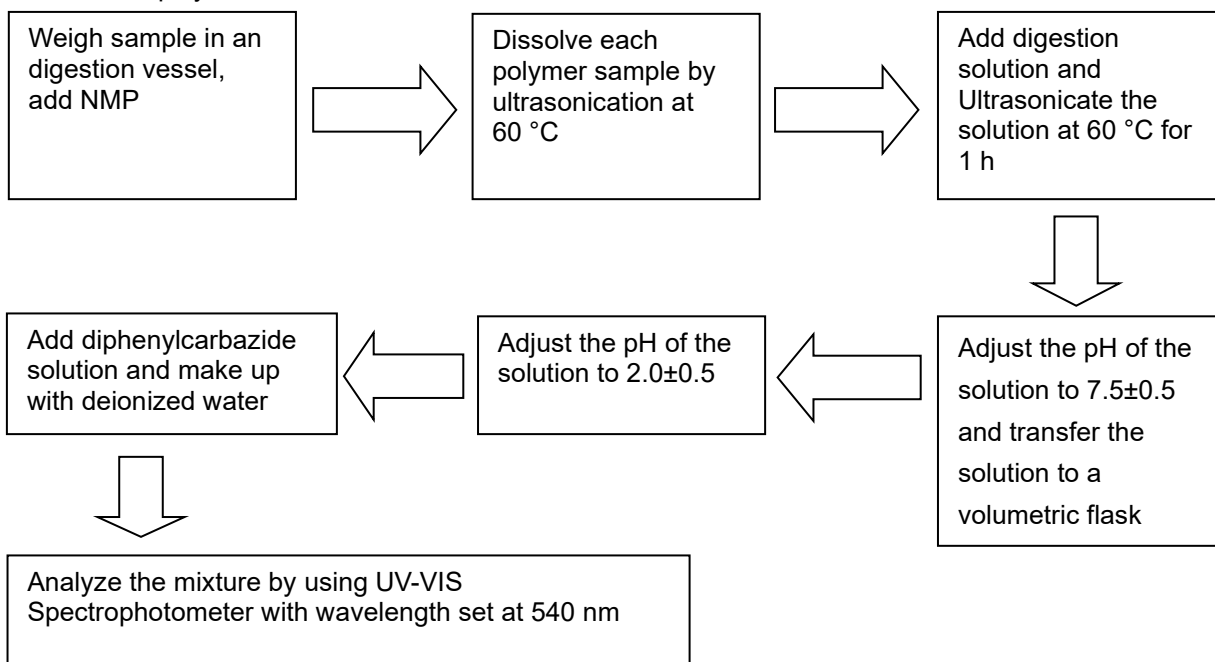


2. Test for Hg Content

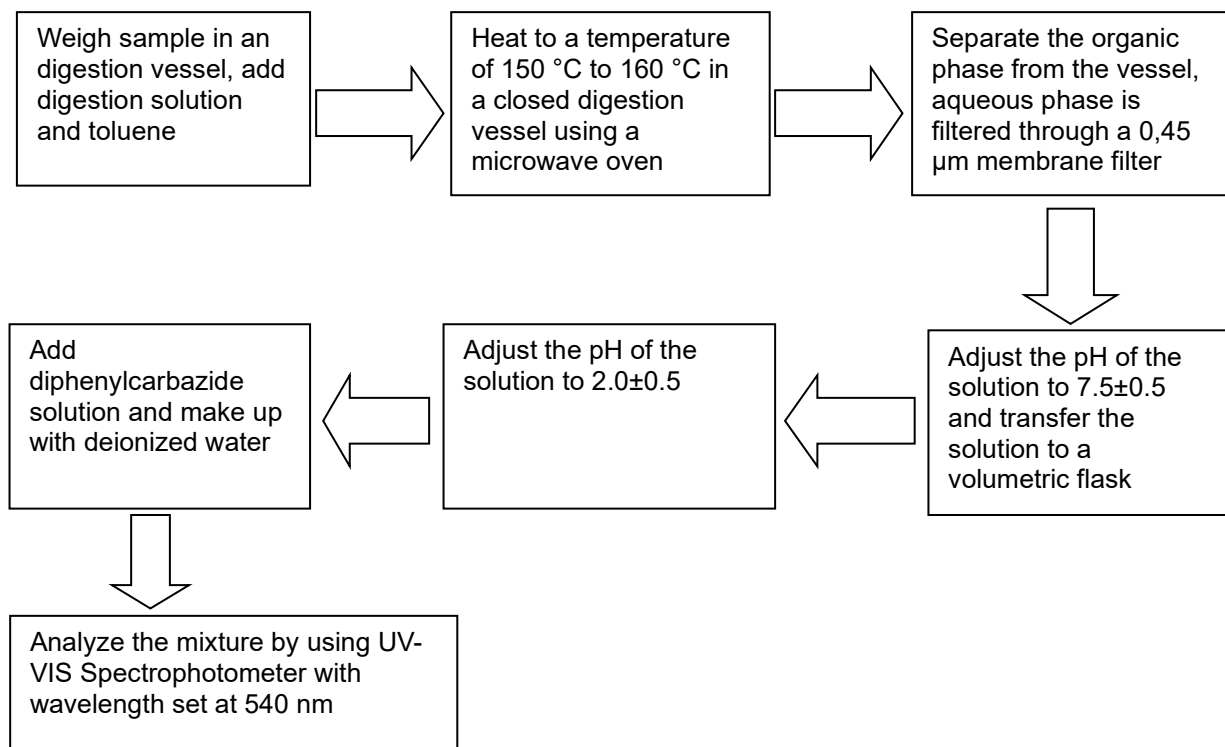


3. Test for Chromium (VI) (Cr<sup>6+</sup>) Content

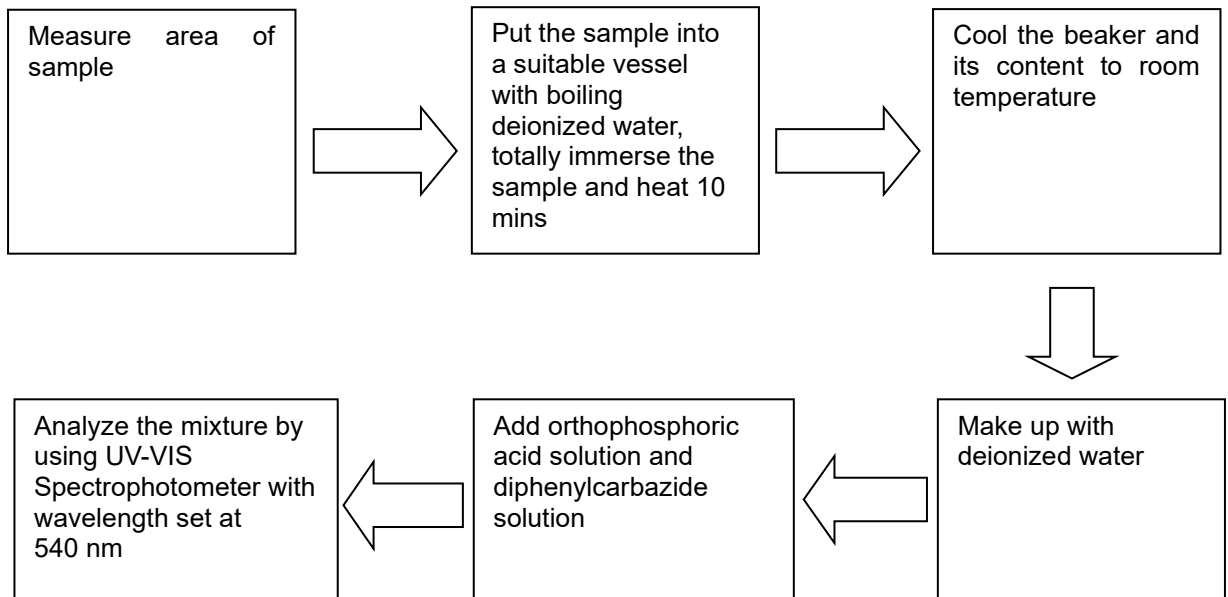

Insoluble/unknown polymers and electronics without Sb:

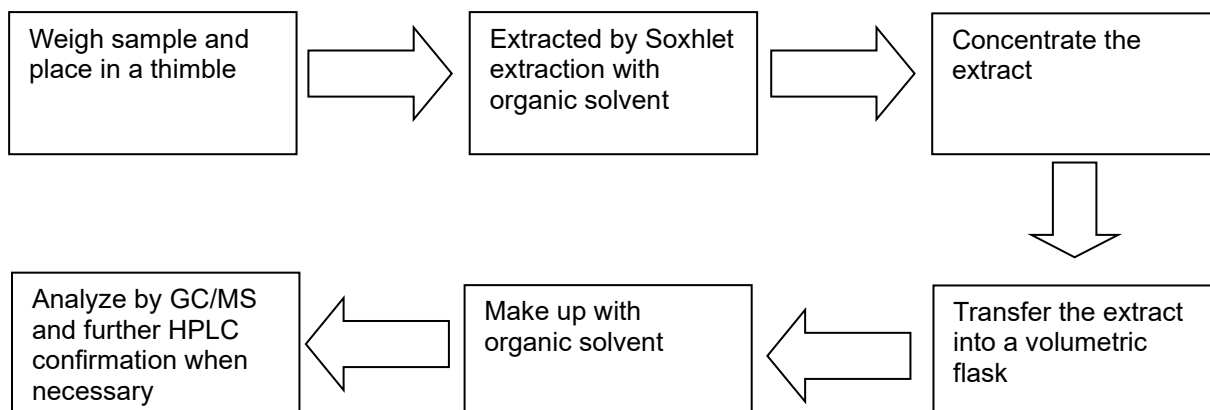


4. Test for Chromium (VI) ( $\text{Cr}^{6+}$ ) Content (Boiling Water Extraction)

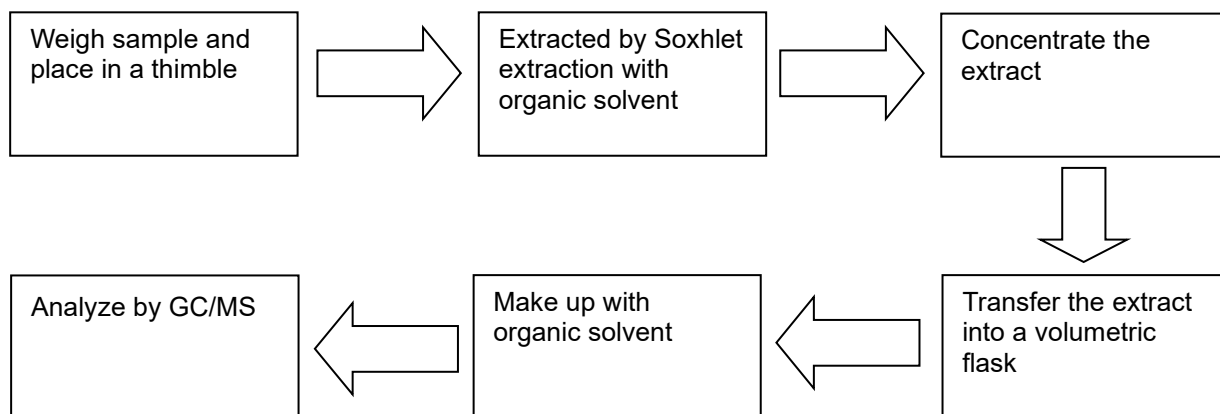




5. Test for PBBs/PBDEs Contents
